## Refining the California COVID Reporting System (CCRS)

CDPH is the largest agency in California, responsible for the public health and safety of 39M Californians. After a year of a single vendor managing the COVID reporting database, CDPH decided it needed to replace both the solution itself and the vendor hosting COVID data reports. Using traditional methods this procurement would have taken 18 months. Using City Innovate's platform for Document Process Automation (DPA) it took only 5 months.

# 16 MARKET RESEARCH PROJECTS (VENDOR DAY)

Part of the EDDNext - an ambitious initiative to remake how the Economic Development Department (EDD) interacts with people seeking unemployment and other forms of assistance - this project involved fielding 16 simultaneous market research projects. Using DPA cut the time required by 50% by streamlining production of the necessary problem statements and enabling vendors to submit their responses through an online portal.
